# **Editorial**

We are delighted to present the combined edition of volumes 75 and 76 of the Journal of Ganganath Jha Campus. We are publishing thirty one research papers in this issue by eminent scholars of different fields of the Indian knowledge system. This volume is decorated with research oriented articles on various branches of knowledge.

'संस्कृतग्रन्थानां वाक्यविश्लेषणं सम्बन्धविषयकचर्चाश्च' - This paper suggests the most suitable methodology for sentence analysis through machine, incorporating Eastern and Western elements. This methodology is derived from experiments and ideas related to the linguistic analysis found in Indian śābdabodha related texts.

'Śaivism in Tripurā' - This paper examines the nature and distinct characteristics of Śaivism in Ūnakoṭi and Tripurā, drawing insights from epigraphical and literary sources.

'Anaptyxis in Indian Linguistic Tradition: With Special Reference to the Prātiśākhyas' - This paper comprises an in-depth analysis of Anaptyxis found in ancient Indian linguistic tradition, specifically focusing on the pratiśakhyas.

'The Theory of Law of Karma (With Special Reference to Bhagvad Gītā)' - This fourth paper provides a comprehensive survey of the karma theory presented in the Bhagavadgītā. This theory has not only impacted the personal lives of Indian individuals but also serves as a motivational resource for philosophers.

'नीति का स्वरूप, आयाम और साध्य (संस्कृत वाङ्मय में नीति तत्त्व विमर्श के सन्दर्भ में)" - This paper presents a thorough examination of ethics (nītiśāstra), including its definitions and diverse dimensions, as depicted in dharmaśāstras, purāṇas and smrti texts.

'The Bhagvadgītā with the World Views of Sāmkhya Philosophy' - This paper elucidates the connection between the Sāmkhya philosophy and the Bhagavadgītā.

'तैत्तिरीयोपनिषद् की शीक्षावल्ली में प्रतिपादित माता, पिता, अतिथि एवं आचार्य में देवत्व की अवधारणा' - This paper sheds light on the concept of divinity in the roles of mother, father, guests and teachers, drawing references from Vedic literature, particularly the Śikṣāvalli section of Taitirīya Upaniṣad.

'Compound Words (Samāsa) in the Indo-Aryan Languages' - This paper

presents a historical study of compound words (samāsa) in the domain of Indo-Aryan languages.

'The Doctrine of Mithyā in Advaita Vedānta' - This paper provides an analysis of the theory of mithyā based on foundational texts of Advaita tradition.

'A Brief Discussion to Establish the Existence of God by Udayana in Nyāyakusumāñjali' - This paper concisely establishes the existence of God based on the eight arguments presented by Udyan in Nyāyakusumānjalī.

'Scientific and Medicinal Evaluation of Harītakī (Terminalia Chebula) in Indian Perspective' - This paper establishes the scientific, medicinal and cultural qualities, as well as the significance of Haritiki in the Indian context.

'वैदिक यज्ञों में अनुप्रयुक्त – ज्योतिष' - This paper thoroughly elaborates the significance of astrology in Vedic yajñas.

'Dharmakīrti on the classification of hetu: A critical Examination' - This paper offers a critical analysis of the concept of hetu in the context of its classification by Dingnagah and Dharmakirti.

'Influence of society in Sanskrit Grammar' - This paper endeavors to demonstrate the influence of society on Sanskrit grammar.

'The Poet Who Captured The Quintessential And Physical Landsacape Of Bharath: Kālidāsa' - This paper delves into the expansive physical landscape

of Bhārata, as portrayed by Kalidasa in his literary works.

'Parallel Meaning Bank (PMB) में प्रयुक्त स्थानाधिकरण सम्बन्धी Discourse Representation Structures (DRS) की विवेचना' - This paper is centred around computational linguistics and focuses on standardising Discourse Representation Structure (DRS) roles for analysing sentences related to the parallel meaning bank. The article describes the application of these roles in sentence analysis.
